PRESIDENT'S HIGH HOLY DAYS MESSAGE 2025/5786

It is my privilege and honor to deliver my first High Holy Days speech to you, and, of course, my wish is for all to have a sweet and healthy 5786. G'mar Chatima Tova, "May you be sealed for a good year" in the Book of Life, in which we are inscribed on Rosh Hashanah and sealed on Yom Kippur.

We will soon rise for the Bar'khu prayer – the Call to Worship Together – and begin the service amidst our community. You may have read that our theme for this year is **Come Together**.

הנה מה-טוב ומה-נעים שבת אחים גם-יחד How good and how pleasant it is for friends to be together in unity.

(Paraphrasing Psalm133)

Allow me to share a short Hasidic Tale.

Rabbi Havim of Tzanz used to tell this parable. A man or woman, wandering lost in the forest for several days, finally encountered another. He/she called out: "Brother, show me the way of this forest." The man replied: "Brother, I too am lost. I can only tell you this: the ways I have tried lead nowhere; they have only led me astray. Take my hand, and let us search for the way together." Rabbi Hayim would add: "So it is with us. When we go our separate ways, we may go astray. Let us join hands and look for the way together." On Yom Kippur we pray communally as we examine our lives over the past year.

How good and pleasant it is for friends to be together in unity and prayer.

Hillcrest Jewish Center has a long history and legacy thanks to the vision and support of many volunteers, past presidents, Rabbis, congregants and friends. In the face of our current challenges, we are resilient and continue to thrive as a unified community.

As we enter these sacred last hours of the Days of Awe, we reflect on the year that has passed, our accomplishments and our challenges. At Hillcrest we do the same.

From Cantor Rachel

From Rabbi Kogan

Dear Friends of Hillcrest Jewish Center,

What are the most important days in the Jewish calendar?

The answer to this question, of course, depends on who you ask. As I mentioned in my d'var Torah on the Shabbat after Yom Kippur, many rabbis believe that the most important days in the Jewish calendar are the 10 days between Rosh Hashanah and Yom Kippur, also known as the Days of Awe. While every rabbi gets extra busy during these days and the few days leading to them, there are many rabbis who build their entire shul-year as a crescendo towards the High Holy Days. After all, these are the days on which most congregants attend services and they present us with a unique opportunity to showcase our synagogues, the work we do, to engage potential new members, and to fundraise for the year ahead. Many of these rabbis "rehearse" services, bring special speakers, and micromanage every single detail to achieve "perfect services."

How do I know so much about these rabbis? Because I used to be one of them. Especially in Argentina, when I was a rabbinical student in charge of a congregation or even during my first couple of years as a congregational rabbi, I spent hours of meetings, rehearsals, and planning for the three most important days in the Jewish calendar.

When we returned to classes after the High Holy Days were over, Rabbi Marshal Meyer, the founder of the Seminario Rabínico Latinoamericano, welcomed us with "tell me about your success!" Both during classes and on one-to-one conversations with colleagues, we shared stories of how successful our services were, how many people attended, how long our *tekia gedolah* was, and how many nice ladies cried because of our meaningful sermons.

This was me over 25 years ago. While I don't look back at those years with regret, it is not where I have been for many years now.

Today I understand that the most important days in the Jewish calendar are the 344 days between Yom Kippur and the next Rosh Hashanah. In other words, for me as a rabbi, the most important days on the shul calendar are the days I spend building the yearly routine of Hillcrest Jewish Center. I measure success not by how many people attended Yizkor, or how long my *tekia gedolah* was at the end of Yom Kippur (actually I believe it was pretty awesome). The truth is that I measure success by how many more people have been joining us for Shabbat, how many people come to minyan, how many of our members know how to lead services, how many successful small groups we have, and how kind our congregants are.

For the few rabbis who belong to this smaller group, the question we ask when we meet after Yom Kippur is not "how successful were you?" but "how did you survive the holidays?" For those who know me it is not a secret that the High Holy Days are a stressful time for me. Yes, these 10 days are important, but only because of the seeds I can plant for the other 344 days that follow.

So, now that I told you about the most important days of the Jewish calendar for me, I hope you really believe that the High Holy Days at Hillcrest Jewish Center were successful, and even more important, that through your involvement, your prayers, your learning, and your acts of kindness (chesed), you help us make the next many days leading to the next High Holy Days, even more successful.

We have a dynamic Klai Kodesh duo – Rabbi Manes Kogan and Cantor Rachel Black. For those who haven't heard, Rabbi Kogan is beginning his 20th year as our rabbi and Cantor Black began her dual position this past July as full-time Cantor and Director of Engagement. Rabbi Kogan and Cantor Black have an effective synergy with each other which benefits all of us. Kol Ha Kavod!

This year we <u>qualitatively</u> increased our programs, events, and classes and <u>quantitatively</u> increased participation. A few weeks ago, we re-activated the Anderman Family Lecture series with keynote speaker, Rabbi Shai Held communicating hope and gratitude, to a packed audience. We increased the number of Small Groups with a variety of topics, leaders and participants. We strengthened our focus on Youth and

Family events, Shabbat dinners and children's services, a core value at Hillcrest. We continued our religious school partnership and engaged our teens in Torah learning.

This year's Yom Hashoah program was an especially moving commemoration featuring a dance performance by the ABCDario Dance Company. Our summer Tea & Schmooze series continues to thrive highlighting our own talented members. It is wonderful that many congregants sponsor a Shabbat Kiddush to enable our community to come together after services.

Our work is far from done. As I stated in my September bulletin article, let's build on where we are and move forward. We are continuing to work on keeping Hillcrest financially viable so that we are assured of remaining in our beloved synagogue for years to come.

It is paramount at the start of this 86th year of Hillcrest's founding that we work together to achieve our synagogue's goals. Just this past Sunday, the Board of Trustees conducted a retreat with the purpose of developing a more effective board, with an updated vision, goals and cohesive practices. We asked hard questions about leadership, recruitment and training, and accountability. An important date to save is Sunday, November 16th at 3 PM for Cantor Black's Installation and Concert.

It is my hope in the coming year that each and every one of you will attend one more class, one more event, one more minyan service than you did last year. Find something that interests you (and your family) and be a part of what brings about change for our community. Connect, participate, and give so that next year we will be a stronger community filled with more gratitude, more giving and deeper connections.

SUNDAY, NOVEMBER 9 – 4:30 PM KRISTALLNACHT The Witness Project: Passing the Torch to the Next Generation

The night of November 9, 1938 is known as Kristallnacht when Jewish homes, businesses and synagogues were attacked by frenzied mobs. This "night of broken glass" marks the beginning of state sponsored terrorism against the Jews of Germany, Austria and the rest of Europe. We recognize this period as the Holocaust.

As World War II ended and the concentration camps were liberated, Jews took up the cry "Never Again." This declaration persists today.

To ensure that a Holocaust never again occurs, it is important that young people are aware of what happened. To that end, Bertha Strauss was involved in the Witness Project with other survivors and college students.

We will be showing the film "Passing the Torch to the Next Generation" about the Witness Project. One of the student participants will be at Hillcrest to speak briefly about the Witness Project and to answer questions.

After the film there will be a special presentation in honor of Bertha Strauss.

BOARD OF TRUSTEES REPORT

Shalom everyone. Here are some highlights from our September meeting:

Executive Committee Report:

At this point, High Holiday seat reservations are slightly below last year's number, but there may be more sales. Screens will be placed in the back of the ballroom. Many have moved into the sanctuary. As of our meeting, 120 accounts have pledged for Kol Nidre. Calls will be made. There have been some increases from last year.

We will have a Board retreat on Sunday, September 28 from 10-1. It is important that all board members attend.

Sanctuary spruce-up: Maintenance has done a nice job. The silver has also been polished.

Reconnect Grant: we received \$3,000 to be used after the High Holidays to encourage people to participate in our events. The first Friday night service on October 24 will be a musical program and dinner.

Dispelling rumors and hearsay, Hillcrest JC is not going anywhere! When the building is sold, we will be leasing it back for at least another 20 years. Our strong programming proves that we are active and vital.

Board members are ambassadors for the shul (name tags will be worn by Board members during the High Holidays).

The Non-member Engagement Committee met and recommended establishing a fee schedule for events attended by people who are not members, such as ongoing classes, small groups, adult education programs, etc. The Board voted in favor of the creation of this fee schedule. The committee will meet and report to the board.

Executive Director Report:

Security on holidays: Volunteers, in half hour shifts, will assist with acknowledging members as they enter the building during the High Holidays. This will be a trial to see if we will continue this activity on Shabbat during the year.

Roof repairs: inspection showed some issues with the roof. The warranty needs to be examined before repairs are made.

There will be a Security Drill on Saturday, September 20 for

about 20 minutes. Frank Diaz will discuss scenarios that may emerge.

A motion was made and passed to purchase 2 computers to act as replacements.

There needs to be annual maintenance on the boilers for safety's sake and to avoid any violations. A motion was made and passed to fund that maintenance.

Sisterhood Report: The Paint and Sip program was very successful. The paid-up membership luncheon with Cantor Rachel will take place on October 27 and the Empowering Women session will take place on November 17.

Men's Club Report: The annual Barbeque was well attended. On Thursday, October 9 there will be pizza in the sukkah and a movie is planned.

Youth and Family Report: September 5 was the first family dinner with 44 participants. November 7 will be a dinner for the children. There will be sukkah decorating on October 5 and a program called "Sundaes in the Sukkah" with Cantor Rachel. We have new leaders for Shabbat youth services: Eliana for teens, Avery for Junior congregation and Elizabeth for Kindershul. Teen Kesher will take place on October 12 led by Yaffa Reichwald. Additional programs have been scheduled through December.

Old Business: The sale of the building is moving along though things were slow this summer. We hope to have lease information available by the November congregational meeting.

New Business: Each committee needs to have a volunteer to check-in people registered for their events. This is not a job for security.

November 9 is the membership meeting.

NEW YORK CITY BINS

It was announced by the Mayor, Dept. of Sanitation and Department of Finance, that owners of one- and two-family homes who receive the Basic or Enhanced School Tax Relief (STAR or E-STAR) credit or exemption will receive a check to pay for the cost of their official NYC Bin. Eligible homeowners will not have to do anything to receive the checks, as Finance will automatically be sending them

As of November 12, 2024, our local properties are required to use bins, 55 gallons or less, with secure lids for trash set out. Those residents who already use a bin of similar size may continue to use it only until June 2026, when they will be required to use the official NYC Bin.

Homeowners who have already purchased their NYC Bin online or by phone will automatically receive a check. Those who have not yet purchased their NYC Bin can purchase their bin online or by calling 855-692-2467 and they will automatically receive a check within 30 days of making their purchase. Those who have purchased or will purchase their NYC Bin in person at Home Depot will receive a voucher code that they can use online, with a proof of purchase, to request their reimbursement check.

TO ALL OUR MEMBERS, YOUNGER AND OLDER

I just received this from AARP... Another rate hike looming for Con Edison customers?

Con Edison recently raised your utility rates, and now they want to increase them again so they can rake in an additional \$2 billion next year. That would mean a 19% increase in the average customer electric delivery bill and a 25% increase for gas. Call the NYS Department of Public Service at 800-335-2120 and tell them to reject Con Edison's proposed electric and gas rate hikes (reference cases 25-E-0072 and 25-G-0073 in your message).

BALLOT PROPOSALS Election Day or Early Voting

When you go to vote, you will find 6 ballot proposals on the back of your ballot. There are notable concerns regarding Proposals 2 to 6.

Ballot Proposals 2, 3, 4, 5 and 6 represent a coordinated effort to strip power from local communities, the City Council, and the Borough President, centralizing control in the hands of unelected bureaucrats and any future

Mayor. By dismantling checks and balances, they weaken your voice in decisions that impact your neighborhood. The proposals undermine the fundamental checks on City Hall:

Proposals 2, 3, & 4 bypass your elected City Council and Community Boards by fast-tracking land use and creating a small, centralized board to override local legislative decisions.

Proposal 5 removes local mapping and control from the Borough Presidents, centralizing essential functions in a Mayoral agency.

Proposal 6 merges City elections with the national Presidential cycle. This change risks drowning out critical local issues beneath the noise of federal politics, meaning your local needs and concerns get lost in the fray of a national campaign.
